LETTER FROM OUR MINISTER

On Sunday 30th November, St Andrews Day, the plaque commemorating the Restoration Project in Kilninver was unveiled. David Kilpatrick did the unveiling and said some lovely words of thanks to all the donors, the trust finds that gave us grants, and everybody connected with the project including Robin Asbury, Treasurer, and Peter Cross, Quantity Surveyor, who planned and coordinated the work. While some small pieces of work remain to be done, including the finishing of the rebuilding of the porch, the

Renovations are substantially completed. A very big thank you goes to everybody concerned and a great sense of satisfaction has been brought in seeing it all done. Some statistics: donations (mainly through pledges) and Gift Aid brought in nearly £29,500; grants amounted to £12,000; and VAT recovered amounted to about £5,000. The major restoration work by Cumming & Co Ltd, Perth cost just over £28,000; electrical work by AMP Oban, £6,500; other works about £12,000. We are all very gratified that the effort to raise the funds was so successful and so much work has been achieved. The plaque in the Church is a permanent record of all who made it possible.

The work for Kilmelford's Restoration has begun, and will continue until late March 2009 for the first phase. Donations and Gift Aid for this have reached the astonishing total of £46,500, and grants have been given or promised amounting to £34,500, totalling £81,000 which will enable us to do the major items of restoration required. The provision of a toilet would require further funding. Once more, we are truly grateful for the enormous support and encouragement given to us in this second Appeal for the Parish Churches.

Our Christmas services are noted elsewhere, and as well as a warm invitation to attend our services each Sunday at Kilmelford or Kilninver on alternate Sundays, we would be particularly pleased to see you at the late Christmas Eve Service at Kilmelford (11.30 p.m.) and on Christmas Day at Kilninver at 11.00 a.m. For me, this opportunity to celebrate the coming of our Saviour is a highlight of the year. We are particularly glad that God loved us enough to send Jesus into our world to make us worthy to be part of his kingdom, to be a real part of his family on this earth. I love the carols. I love the Christmas readings, but I love the opportunity to share this great truth that we are God's people because he loved us enough to send us Jesus.

Christine joins me in wishing you all a very happy and joyful Christmas, and a good New Year when it comes.

The Cherish Fund (Oban)

In memory of Alyson 1974–2007


In February 2005 aged 31 our daughter, Alyson, was diagnosed with stomach cancer and after a courageous battle she died at the end of May last year.

For the last four weeks of her life she was wonderfully cared for in Oban, Lorn and the Islands Hospital, although quite a large hospital by rural standards it still has that lovely cottage hospital feel to it. About a week before she died she had to go for specialist treatment to Glasgow Royal where she had had her initial surgery. This is the downside to living in a beautiful rural area. She was taken by passenger transport!

To the uninitiated this vehicle is rather like a minibus, which goes all round the various hospitals where patients have their appointments and you can be travelling for anything up to four hours each way. I have a friend who drives these vehicles and she tells me it's the saddest part of her job.

We set up a charity in Alyson's memory called "The Cherish Fund (Oban)". The aim of the fund is to buy a vehicle, which can be customised to transport terminally ill patients in comfort and dignity to wherever they need to go, be it Glasgow hospitals or just the Day Hospice to give their family respite.

LIGHT UP A LIFE 2008

Prior to Christmas 2006, Friends of Oban Hospice successfully engaged in the Hospice movement Christmas campaign 'Light up a Life' when over £18,000 was raised by the public in Oban, Lorn and the Isles for local Hospice funds.

In 2007, individual residents in a few of the islands and outlying districts around Oban, ran their own local small scale versions of 'Light up a Life' by inviting friends and neighbours to an informal social event either at their home or other venue where, if possible, a tree was lit up in memory of departed loved ones and a collection taken and sent to the main campaign in Oban.

Last Christmas we organised a similar event here in Kilmelford and raised £300. If you wish to make a contribution you should find a flyer included with this newsletter with information on how to do so.

Once again this Christmas, there will be a short service held at the Christmas tree at the Melfort Club on Thursday 18th December following the arrival of the Kilmelford Carol Singers. All are welcome and the singers will also be making a collection for a local charity.

Committee meetings of the above association were held on 16th September and 11th November 2008. The main topics under discussion were as follows:

Maintenance

- a) The painting of the small hall, main hall, balcony, passageways and lobby is now finished. The labour was provided free of charge by workers on an Employability Scheme. We intend to paint the kitchen and main hall skirting board early in the New Year; any helpers would be warmly welcomed!
- b) The caretaker has cleared out the bird's nest that was blocking the outlet from the extractor fan in the kitchen. He has also replaced the sealant around the windows in the lobby, fitted support brackets to the Gents' washbasin and attached a draft excluder to the back door.
- c) A builder was called in to fit a membrane between the concrete and wood floor at the back door of the main hall where water ingress has caused damage.
- d) Regarding the additional heating for the main hall, an estimate £4162 has been received from Oban Electrics to fit downflow heaters on the walls, with associated work. As this is beyond our budget, and the situation regarding funding is uncertain, alternatives are being sought.

Fund Raising

- a) The Mull Theatre production of Macbeth attracted an audience of 62 and raised a total of £103 from hire of Hall and sale of teas.
- b) The Car Boot Sale successfully raised £179, thanks to the efforts of Caroline and Fergus Gillanders.
- c) Toni Mitchell has written to the Corporate Funding Officer for Argyll & Bute to ascertain whether funding for the additional heating would be available.
- d) The highly popular Hogmanay Party and Race Night (20th Feb) are to be held again.

The AGM will be held on 27th January 2009 at 8.00pm in the Village Hall. Your comments and opinions would be most welcome (or possibly not!)

THE "NEW LOOK" VILLAGE HALL

Those of you who have visited the Village Hall recently will have noticed the 'new look'. The walls of both halls and corridor have been re-painted.

My reasons for doing this in the main were two-fold. Firstly maintenance, as I don't believe the walls have been painted since the hall was built just over eleven years ago. The white walls lower down were quite badly marked with black scuff marks and really needed doing. Secondly, to make the hall look WARMER, brighter and more welcoming, as I felt white everywhere, especially with a grey carpet, did little to cheer.

The choice of colour was an agreed compromise after discussion with various groups of people who use the hall. The Grecian Spa of the lesser hall was the Art Group's choice, but as they use it 51 weeks a year, I felt that was fair. The three colours of the corridor and the main hall are off the same palate, just shades on the theme of 'Mango'. Not originally my choice but other suggestions, bearing in mind I wanted a 'warm' colour, were met with comments from 'old ladies knickers' to less printable terms. What we have seemed to meet with most people's approval. Sadly the paler shade on the long and stage walls in the main hall does not reflect the true shade because of the lighting, sorry. Nevertheless, I think you must all agree every where looks brighter, cleaner and certainly warmer.

The next question I can hear you ask, is "What did all this cost?" Answer, the price of the <u>paint only</u>; approximately £255. Thanks here to Tony at Craigard Decor who gave us a wonderful deal on the Dulux paint.

About three months ago I filled in a form asking Argyll and Bute Council's Employability Team if this redecoration could be done. There were apparently 66 applications from halls wanting some kind of work done but we were lucky enough to be short listed to the final six. It was then all systems go and a team of three worked on it the first four days of week one and a team of five the second four days of week two, as they don't work Fridays. If you think of what that would have cost if we had had to pay for it, the bill would have run into thousands. Under the impressive leadership of Alan McIntyre, it was soon obvious that two coats of paint would be needed everywhere and the team had only been give the two weeks in which to do the job. So I called upon some volunteers. My thanks to Dorothy Bark, Ellen and Philip Coyle, Christine MacLachlan and Clare Howard who spent a morning with me masking up, and my special thanks to Georgina who spent last Monday with me painting the corridor and to her and Clare for going in on the Tuesday to do some more painting. This meant that it all got done on time. Thanks too to the ladies that went in with "goodies" to help motivate the workers, this I know was greatly appreciated. I think you must all agree that for a team of 'non professionals' a very professional job has been achieved, for which I feel Alan McIntyre deserves the accolade; I have of course written to the Employability Team to express our thanks and appreciation for a job very well done.

DRAFT MINUTES

The meeting of the above Council was held on Tuesday 14th of October 2008 at 8pm in the Village Hall

Present: Robin Asbury (RA) Chairman, Lindsay Davies (LD), Robin Grey (RG), Nigel Mitchell (NM). Also in attendance were Cllr Donald McDonald, Fire Station Commander Ian McMeekin, Fireman David Millward and 17 members of the public.

- 1. Apologies: Alasdair Oatts, Cllr Elaine Robertson and PC Kevin Moffat.
- **2. Minutes of previous meeting:** Before approving the minutes the Chairman read from the Kilninford News with the intention of clarifying several issues. The Kilninford News will always print all minutes of Community Council Meetings since the last edition of the Kilninford News. The only Draft Minutes that may be printed are those which will be approved at a meeting within 2 weeks of the circulation of the Kilninford News. Where there is time gap of more than 2 weeks the Community Council will post the draft minutes on the 2 official notice boards at the same time as the Agenda is posted for the next meeting.

The minutes of the meeting on 5th of August 2008 were taken as being a true and accurate representation of that meeting. Proposed RG, Seconded NM.

3. Matters Arising from previous meeting:

- a. Roads Issues Stewart Clark has confirmed that the white lines issue has been added to a list of works.
- b. Speed Limit No further info. The Chairman suggested that when any action on this item we should seek to extend the limit to include the new houses, south of the Glebe, to just beyond the Degnish Road End.
- c. Bus Shelter in Kilmelford Stewart Clark has confirmed that the shelter is being delivered to the depot this week. NM confirmed that all component parts are in the depot and Kilmelford will be installed as a priority.
- d. Blaran Road End the Chairman stated that it appeared a satisfactory stalemate had been reached regarding the bus pick up/drop off. Children are picked up at the Glengallan lay-by and dropped

- off at Kilninver Primary School. This issue will be dropped from the agenda now with the possibility of the issue arising again.
- e. Insurance for Kilninver Notice Board- RG stated he was having difficulty getting a quote for this. Cllr McDonald was not aware of this as an issue but will enquire on our behalf.
- f. Problem weeds in Scammadale- the Council confirmed they have a limited budget for roadside weeds via Roads Budget. Cllr McIntyre has forwarded information regarding Strachur Community who have tackled their problem weeds. LD in receipt of this info should the Community wish to take forward.
- g. Sight Lines in Arduaine-There is now an agreement by the Roads Department that the sight line is okay. Fence still on land is is to moved by agreement. Hedge is still in place. Cllr McDonald confirmed that if the sight line is not enforced in 15 years then it lapses. John Stannard added re the height of hedging by the mussel farm. Recommended height is 1.2m. The Enforcement Officer has now got additional duties which will add to the difficulty of enforcing these sorts of things. To continue monitoring.
- h. War Memorial- email received from Cllr. McIntyre. Kilmelford memorial is known to be requiring work however there is not any suitable equipment to carry out this and other works in the area. Remedial works will not be done in time for Remembrance Sunday. The Council does intend finding a way of dealing with the memorial in order to make it safe.
- i. Data Protection Act 1998- LD has looked at the literature available and it looks as if we will be required to register in order to comply with this, LD to continue with this issue.
- **4. Presentation by Fire Officer:** Mr Ian McMeekin, Commander at Oban Fire Station gave a presentation of what service they offer as well as fire fighting and attending roads traffic accidents. Lots of emphasis on fire prevention and working with the local communities. You can contact Ian via a local fire-fighter or at Oban Fire Station on 0800 0731 999.

The local fire service is trained to carry out Home Fire Safety visits and provide advice and fit smoke alarms free of charge.

In October 2006 legislation was passed that affects B&B's/self catering/shops. They must have a fire risk assessment. If there are more than 5 employees or the premises are licensed they must have a written report. The onus is on the individual to be responsible for their premises.

The Fire Service has carried out a Young Drivers Project working with 17, 18 & 19 year olds in Oban, Lochgilphead and Campbeltown. They are also participating in an Education event for P4, 5 & 6, doing presentations to all schools.

Commander McMeekin is keen to have ongoing contact with Community Councils.

Georgina Dalton added she attended a fire service course, through the self-catering association and found it very useful.

5. Land around Kilmelford Hall:

Cllr McDonald confirmed that the Lorn Plan will not be ratified until the 27.11.08. The Report done on the Plan recommends that the Rural Opportunities Area be reduced. The Local Councillors are not in support of this. The Local Plan does not include the land around the Village Hall and the Reporter does not approve changing this. Adrian Jackson Stark, Local Plan Officer, is to visit Oban re Local Plan. It is likely that there will now be a delay of several months before we know the outcome as it then goes back for Public Consultation, then to the Scottish Executive who has 28 days to approve it. Cllr McDonald confirmed it now looks unlikely that a competent motion will be prepared but we can write again in support of our proposal. RA to action this.

Georgina Dalton had asked previously regarding the affordable housing if there was a stipulation in the planning consent as to where in the order of build they should come. RA enquired of the Planning Department and there is no stipulation in the planning consent. The Community Council will write to West Highland Housing Association to clrify the position of the affordable housing.

6. Planning Applications:

RG stated there are 2 planning applications

1. Erection of dwelling house, land NW of Bragleenbeg, Scammadale. Some local concern that this is outside the Local Plan and has already been refused once.

2. Scottish Water- small extension of working area at Degnish Road end Sewage Site.

It was added by Cllr McDonald that the Planning Department would value feedback, from the Community Councils, on all applications that affect them both positive and negative.

- b. Toni Mitchell, as Chair of Village Hall Committee, advised they had applied for a Wee Green Grant to pay for painting the inside of the hall. The bid has been short listed to 20 and will soon be told if bid successful.
- c. Telephone kiosk, after many calls regarding kiosk not working it has now been repaired.
- d. NM raised the issue of damage on Kilninver Bridge- being kept an eye on at present.
- e. RA raised the issue of damage to the high tide marker. Having discussed with Stewart Clark he has been informed this does not come under the Council's remit. The Chairman asked if there were enough funds in the CC Account. Sandra Duncan, A&BC will assess and fix with Community Council funds.
- f. LD raised an issue on behalf of a Scammadale resident regarding a proposed development of 5 linked houses adjacent to Cuil Darroch. It lies outwith the local plan, is not in keeping with local building and many residents of Scammadale are in opposition. The Community Council has not had notification of this but is aware of it. RA to write to the planning department in opposition.
- g. John Stannard advised those present of a recent incident in the Arduaine area regarding forestry felling that caused the water supply to be contaminated. With good communication between the company and the community felling was halted and the problem repaired. He emphasised the importance of local communities developing and maintaining good communication links with contractors in their area.

- h. Community Engagement Meeting-NM attended this meeting. He noted that at the next election CC boundaries may be changing. Also, if we choose to do a postal ballot we can claim for postage.
- i. Cllr McDonald advised of an application for a grant for £10m for development of the harbour and bypass in Oban. If this bid reaches the finals Cllr McDonald will give a presentation to the Community Council.
- j. Oyster pickers were noticed at the head of the loch. A member of the public phoned the relevant authorities and the individuals were picked up.

The next meeting of Kilninver and Kilmelford Community Council will be held in the Kilmelford Village Hall on Tuesday 9th of December at 8pm. With our Chairman unavailable for this meeting, the Community will be notified if a Quorum is not available.

There being no further business the Chairman closed the meeting at 9.50pm.

Vehicles Exceeding the Speed Limit Outside Kilninver School

Over the past few weeks, several parents have contacted the Parent Council and voiced their concerns about vehicles, some driven by members of our local community, who are not observing the speed limits whilst driving past the school.

We understand that despite the clear signage, some drivers are travelling at speeds almost double the limit and on occasion, vehicles have overtaken on the stretch past the playground. Obviously this has major safety implications for our children and the Parent Council feels that drastic steps have to be taken to try to combat this irresponsible and dangerous practice.

To this end we have contacted both Strathclyde Police and Argyll & Bute Council to ask for their assistance and we feel sure that we will have a positive response from both.

We would like to remind the members of the community that the speed limit past Kilninver School is 20mph when the lights flash between the hours of 9.00 - 9.30 am. 11.30 - 12noon and 3.15 - 3.45pm At these times, there are children walking to and from the school who, due to their close proximity to the road when walking along the pavement, are exceptionally vulnerable. Outwith these times, the Speed Limit is 30mph.

The Parent Council would appreciate anything you can do to help us in reducing the risk to the children as they travel to and from school.
